INTERNATIONAL AWARDS HANDBOOK ACTIVE 20-30 INTERNATIONAL





Guide of International Awards Active 20-30 International Abstracts

1. "Ken Helling" Public Speaker of the Year Award

This award is given to the member representing a National Association and who presents a speech of 5-7 minutes in the International Convention of a topic chosen by the International President. The participants will be scored by a panel of judges.

2. "Norman Morrison" Public Relations for the Year Award

This award is presented to the club which has done an outstanding job of promoting the name, principles and ideals of Active 20-30 in its community and thereby enhancing its prestige. There will be two awards, one for communities with a population of one-hundred thousand (100,000 or more) and one for clubs servicing a population of less than one-hundred thousand.

3. "Paul Claiborne" Distinguished Club of the Year Award

This award is presented to the club that has demonstrated outstanding involvement in its community through fundraisers, projects, visits as well as outstanding participation in national and international campaigns.

4. "Ernest Ax land" Charity Project of the Year Award

This award will be presented in two categories: 1. to the most outstanding Project that has benefited a population of less than one-hundred children and 2. For the most outstanding project benefitting a population larger than one hundred-children.

5. "Alexander Fletcher" Development and Expansion Award

This award is presented to the club or National Association that may have contributed the most to the development and expansion of Active 20-30 International.



6. "George Graziadio" International Relations Award

This award is given to the Club that has distinguished itself in promoting international relations.

7. "Manuel Molina" National President Award

This award is presented to the National President that has demonstrated his/her interest in the development, growth and future of our organization 20-30. For this award there is no required submission; it is presented by the International President and International President Elect.

8. "Ruben Salas" Web Page of the Year Award

This Award is given to the club that has published the best website which has to include information of the club, its affiliation to the national association as well as its affiliation to Active 20-30 International.

9. "Best Scrapbook" Award

This award will be presented to the club with the best scrapbook. In order to be eligible, the book must be present at International Convention, once this book is evaluated by the Awards Committee it will be in exhibition in the General Assembly hall.

10. "Best Pin" Award

Given to the club, National Association who designed the best pin in Active 20-30

11. "Erick Guillermo Arauz" Environmental Project International Award

Given to the club that demonstrated the biggest effort in developing projects and activities to protect ecology and the environment.

12. Leadership through Education in Active 20-30 Award

Given to the member who has being part of the Organization with more correct answers in a test based on the information included in handbooks, bylaws, and Roberts Rules.

13. Best Project that Promotes the Education, Practices and / or Promotes Civic, Ethical and Moral Values

Given in recognition to the club that implements the best project or action that promotes education, practices and / or promotes Civic, Ethical and Moral Values.



General Rules

All awards will be given based on the criteria for each of the categories of activities developed by clubs during the past administrative period, from June 1st to July 30th.

Each Association must submit a message to the International President, outlining the names of the awards for which they will compete based on the winners chosen at the National Convention. This letter must be submitted 30 days before the International Convention and can be sent in whichever form the association considers most appropriate, including electronically and can be sent in either English or Spanish. Please note that if there are two winners of the first place in a National Association, only one of them can participate.

The International President will provide, 15 days before the beginning of the Convention, the names and electronic e-mails of the members of the awards committee of his choosing. Each association will have to send their nomination packages in both English and Spanish so that they can be scored by the committee prior to the convention.

Each member of the Awards Committee will analyze individually each nomination package and grade according to the scoring board of each category. These grades will be taken to the International Convention so that on the day of the Annual General Assembly, the committee breaks only for two hours to discuss the details of their grades, consolidate scores and choose the winners. Only in exceptional cases, when participants have acquired the maximum amount of points and present outstanding work, will the committee allow a tie for the awards that may merit it. In these cases, there must be substantial written explanation presented to the International President along with the rest of the winners of other categories so that it may be announced at the closure of the convention.

The documents presented can, if the contestants choose, be returned to them once the Awards Committee has ended its duty or can be left as material for records of the history of the Organization, Association, Clubs and members.



1. "Ken Helling" Public Speaker of the Year Award

KEN HELLING. He was President of Active International in 1959, precisely in the same year in which the first conversations around the merging of Active and 20-30 started.

The eligible participant will be the winner of the Speech Award chosen during the National Convention of his/her National Association and will have to register for the contest at least 48 hours prior to the inauguration of the International Convention.

The International President, International President Elect or any National Presidents or members who have held those positions previously cannot participate in this contest. The topic will be chosen by the Outgoing International President. The panel of judges will be comprised by a minimum of three people, preferably with experience in judging speech contests professionally. The judges, because of the importance of the contest, will have to be bilingual.

As an incentive to the contestant and in attempts to stimulate greater participation in Active 20-30 as well as to awaken aggressiveness in youth and dynamism oriented in the formation of leaders, it is suggested that the Club hosting the International Convention exempts the winner of the contest from convention fees. Each National Association, following the policies of Active 20-30 International, must promote a Speech Contest in its National Convention. As a stimulus to participants, the National Association will offer the winner of its contest, the payment of the fees for the upcoming International Convention. The award to the winner will be applied to the cost of his or her trip. If any Association has the economic means, it can give a better award to the winner of the contest, by including the payment of 50% of transportation costs to the International Convention.

The speech has to mention the theme or topic chosen by the International President, has to last at least 5 minutes and no more than 7 minutes and will be scored with the following chart:

IMPORTANT: Public Speaking is the art of speaking with eloquence. Before planning an intervention it is necessary to know the place in which the speech will be given so that this does not influence the nature of the speech. Behavior as well as presentation, posture, language and body language have to vary according to the place we are. Do not look at the clock, watch the tone; this is not a conversation much less a workshop. Look always in the eyes of the audience and maintain a proper tone of voice. Verify the surface of work and avoid excessive movements.



2. "NORMAN MORRISON" Public Relations Award

NORMAN MORRISON. He was president of 20-30 International in 1959, year in which the conversations for the integration of Active and 20-30 started.

One of the phrases to define public relations can be found in the Bible: "let your light shine before men, that they may see your good deeds" (Matthew 5:13-16).

The bestselling strategy in the world is that which begins and ends with a constructive program serving the community.

Promoting Active 20-30 through publicity and public relations improves the relationship with local groups and stimulates the growth and formation of new members.

We strongly believe that we have to distinguish and appreciate our clubs for their work in Public Relations because when their work is well developed, it showcases the principles and ideals of our International Organization.

The aspiring club to this distinction has to submit to the International Presidential Council (meeting prior to the International Convention) a detailed report of its complete Public Relations Program. This report has to be supported by clear and objective proof (for example: photographs of events, announcements and ads, newspaper and other publication articles, television and radio programs, etc.). Along with this report the participating club has to submit a copy of monthly reports that it has submitted to the National Association. The National Association, through its President or President Elect, will support the goodfaith of the submitted material. The International Presidents Council will use the following scoring table, giving grade from 0-10 in each category.

Note: This recognition will be granted in two categories:

One for communities with a population larger than 100,000 inhabitants
One for communities with a population of less than 100,000 inhabitants

3. "PAUL CLAIRBORNE" Distinguished Club Award

PAUL CLAIBORNE. He was the young 20-year-old that had the idea to form a service club for young men which happened in Sacramento California in the fall of 1922. With this idea he established the Club 20-30 and became the first President of 20-30.

There are clubs within our organization, that aside from their membership (quantity and economy) develop significant Projects to benefit their communities as well as the daily duties within our organization. Such qualities make our club stand out as true organizations of services.

These clubs deserve recognition, support and stimulation from the International Organization. There are clubs where membership improves in quantity and quality, which results in better projects when their hard work is recognized.

Therefore, we consider that it is necessary to bring recognition to the club that fulfills the following requirements:

4. "Ernest Ax land" Charity Project of the Year Award

ERNEST AXLAND. He was a founding member of Club Active, which was the club formed by a group of Young men in Aberdeen, Washington in February 1922.

Clubs all throughout Active 20-30 develop outstanding projects of social and civic importance. These projects must be acknowledged locally, nationally as well as serve as international examples. The way in promote this project can help these become an example and stimulus for other clubs so that they can develop and execute more ambitious projects.

To be able to participate in this category, the interested Club has to present a detailed report with sufficient copies in English and Spanish. The International Presidential Council in the meeting prior to the opening of the International Convention will score the information or will designate for this purpose, a commission that will be formed by members of the Council.

The interested club has to assign a delegate who if according to the politics of the Council is requested to present and explain the Project to the International Council is able to do so. The committee assigned for this will have 10 to 15 minutes to listen to the presentation, if there is one.

We believe that the way in which a club of Active 20-30 brings its name forward in its community is through projects benefiting children. The importance of this award lies in the need to promote and recognize, nationally and internationally the projects of Active 20-30 in places where it is represent ended, and whose development brings great social and civic benefit whether through fundraising or other activities for the benefit of children so that these may serve as an example and stimulus to other clubs, so that they may develop and execute better and more ambitious projects.

12. "Jorge Mario Hernández Moreira"

Leadership through Education in Active 20-30 Award

JORGE MARIO HERNÁNDEZ MOREIRA. He joined the organization when he was a teenager. He was part of the chartering members of the Active 20-30 Youth Club of Tres Ríos, Costa Rica. He was sworn as president of the Active 20-30 Club of Tres Rios in 2011 and as National President of his Association in 2013. During his time in this Club, he was part of the chartering process of two Clubs: the Active 20-30 Clubs of Limon and Perez Zeledon. Years later, in 2017, he would be involved in would become charter member of the Active 20-30 Club of Metropoli which he represented as president during the 2018-2019 term.

In our history, Active 20-30 International has engaged in the idea of promoting leadership through servicing our communities; nonetheless, one of the main principals to achieve this is education. This helps us to improve our public speaking and writing skills for meetings, conferences, and interviews. This also motivates us to ask for bigger and more difficult challenges.

It is important that new members learn about our philosophy and our bylaws since we are all committed with our Organization and the possibility of helping it grow for it to be active for many years.

Objective:

To give a test to different members of Active 20-30 International where they will answer 50 questions about history, politics, bylaws, and Robert's rules of order.

Requirements:

- Being an active member with less than three years in the organization.
- There is no restriction in the number of participants and there will be no limit either in the number of members of each National Association that participate.

Rules and Scoring:

The International President or a Life member of his/her choice, will design the test and will provide the answers for each question. This will be given to the members during our annual International AGM.



This test will be designed and given to members in both languages -English and Spanish. It will have a total of 100 points (2 points per question) and will be graded by a jury -two Life members or two members with great experience in the Organization. This jury needs to be present during the International AGM and they will grade the test using the answer key previously provided.

The Convention host needs to provide a room for members to take their test. This needs to be quiet and private for members to concentrate.

The time allotted to complete the test is no more than 2 hours. In case of a tie among the participants, the jury will call the members to ask them three questions that they will answer in an oral way in front of the International Delegates during the International AGM.

The member who correctly answers most of the questions will be determined the winner. This member will receive 50% of the total cost of the International Convention fee as his award.

Among the contents for this test are: International handbooks, Active 20-30 International bylaws, International Agreements or Politics, Robert's Rules of Order that are available online. None of these materials can be used as help during the test by the members.



13. Best Project that Promotes Education, Practices and / or Promotes Civic, Ethical and Moral Values Award

This award will be given annually during the International Convention, as a recognition to the club that implements the best project or action that promotes the education, practice and / or promotion of Civic, Ethical and Moral Values.

The prize in question will be selected by an award committee appointed during the international convention, following the agreements and parameters agreed upon and determined by the International President for that purpose.

The recognition will be granted to the club that in the year 20-30 immediately preceding, has implemented a project or action directed to the community where it operates or at a regional, national or international level and especially to children and / or youth.

No club can aspire with the same project or action in more than one occasion.
